

What Is the Anion Gap and Why Does It Matter?

The **anion gap** is a calculated value that helps healthcare providers assess **acid-base balance** and recognize hidden causes of **metabolic acidosis**. It compares the main measured **electrolytes** in the blood, especially **sodium** and **chloride**, to judge whether unmeasured acids are accumulating in the body. When the gap is higher than expected, it often signals an **acid-base disturbance** caused by **unmeasured anions**.

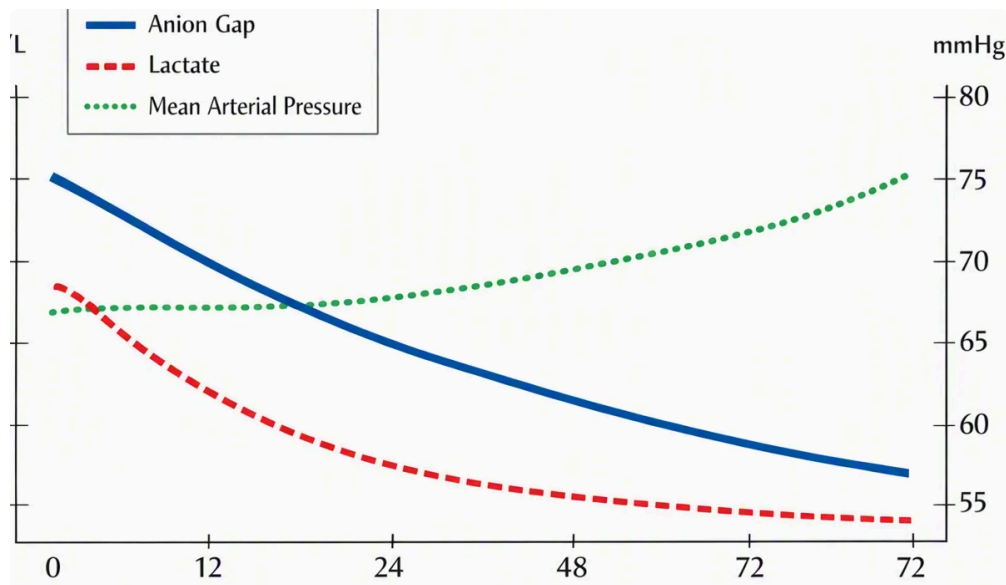
When to Seek Emergency Treatment

Ethylene glycol poisoning requires **emergency care**. If ingestion is suspected, treatment should not wait for every confirmatory test to return. The condition can rapidly progress from an early osmolar disturbance to dangerous acidosis, organ injury, and life-threatening complications. Prompt action can prevent irreversible damage.

The main **antidote** is **fomepizole**, which blocks the metabolism of ethylene glycol into its toxic acids. By stopping the conversion to glycolic acid and oxalic acid, fomepizole reduces further acid accumulation and limits progression of **anion gap acidosis**. It is often started when clinical suspicion is high, even before the diagnosis is fully confirmed.
