

A truck wreck is not a car wreck. A loaded tractor trailer can weigh many times what your car weighs, and people tend to get hurt much worse.

The difference starts in the first hours. The trucking company often sends its own people to the scene within hours, while you are still in the emergency room. They start protecting the company immediately.

More than one company can be responsible. The carrier, a maintenance provider, a broker, or the company that loaded the cargo may each share responsibility. Each of those is its own question with its own evidence.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
