Georgia law sets an order for who may bring that first claim. When there is a surviving spouse and children, the law also sets a floor [truck accident lawyer](#) on the spouse's share.

Deadlines apply, and some of them are shorter than the general rule. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also disappears, especially when a company vehicle or a business is involved.
