

When a dog attack leaves someone hurt in Georgia, [truck accident lawyer](#) the legal standard surprises most people.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

These records fade fast. Prior complaints and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
