

If an electrical injury happened at work in Georgia, there is usually more than one responsible party.

There is the property owner, the general contractor, the electrical sub, sometimes [commercial truck accident lawyer](#) a utility, sometimes an equipment manufacturer, and sometimes a staffing agency. Each has different insurance and different incentives to point at the others.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, and none of that is available just for the asking.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
