

When a dog attack leaves someone hurt in the Atlanta area, the legal standard surprises most people.

Some states hold the owner responsible no matter what. That <https://www.empowher.com/user/4917603> is not the Georgia rule. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

These records fade fast. Animal control files and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
