

If you ride and a driver did not see you in Atlanta, you are starting from behind.

There is a built in bias in motorcycle claims: that the rider was going too fast, was lane splitting or weaving, or accepted a risk nobody else would.

Occasionally that is true. More often a driver looked and did not register a single headlight.

These cases get built on physical evidence rather than narrative, because narrative starts at a disadvantage. Damage patterns carry more weight than either version of events.

Severity helps and hurts. A rider has no structure around them, so [truck accident lawyer](#) identical forces cause much greater harm. Expect an argument that choosing to ride was itself the risk.
