

If you were hurt on a bus in Atlanta, the timeline is not the usual one.

An ordinary Georgia injury claim generally **Take a look at the site here** allows two years to file. A claim against a city, county, transit authority or school district can require written notice in a fraction of that time, in a specific form, to a specific office.

Missing that notice can end an otherwise strong case before it starts.

Who owns the bus drives the analysis. Injuries on a public transit bus, a school bus, a private charter and a hotel shuttle each run on different rules. Ownership sets the notice requirement, the immunity questions and what insurance responds.
