

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer turns on what the app was doing when the crash happened.

If the app is off, it is an ordinary car wreck, and their **top personal injury firm Atlanta** personal policy applies. Once a ride is accepted or a passenger is aboard, a far larger commercial policy usually applies.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each position can reach a different layer of coverage.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
