

When a rider is hurt and a driver did not see you around Atlanta, there is a prior you have to overcome.

People arrive with a view already formed: that the rider was going too fast, was lane splitting or weaving, or accepted a risk nobody else would.

Occasionally that is true. More often a driver looked and did not register a single headlight.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. Damage patterns do the arguing.

Injury severity cuts both ways. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
