

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one eventually, usually when the bills arrive or an insurer calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. One belongs [The original source](#) to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious suffering before death.

Who may bring the first claim follows an order set by statute. It generally begins with a surviving spouse, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some of them are shorter than the general rule. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, especially when a company vehicle or [truck accident lawyer](#) a business is involved.
