

When someone is shocked or burned on a job site around Atlanta, there is usually more than one responsible party.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim against **car accident settlement lawyer** a third party whose conduct created the hazard.

That third party claim is usually where the real recovery sits, since comp covers none of the human [truck accident lawyer](#) loss and only part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, and none of that is available just for the asking.
