

If a dog bit you in the Atlanta area, the rules may not be what you assume.

In some places an owner is liable automatically. Georgia is not one of them. The claim generally turns on whether the owner knew the animal was dangerous, or whether a leash law was being broken at the time.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

Records disappear quickly here. County records and witness memory both degrade, and the animal may be rehomed or euthanized before its history is [18-wheeler liability lawyer](#) ever documented.
