

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one eventually, usually when the bills arrive or an insurer calls.

Georgia treats a death case differently than people tend to assume. There are generally two separate claims. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. It generally [truck accident lawyer](#) begins with a surviving spouse, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also disappears, especially when a company vehicle or a business is involved.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
