

What Is the Anion Gap?

The **anion gap** is a derived value that helps estimate the difference between the main **electrolytes** measured in blood chemistry. In practice, it is used as a fast way to evaluate **acid-base balance** and identify patterns that may suggest an **acid-base disorder**. This is the most effective way to turn a basic calculation into a meaningful clinical pattern. The result is not just a number; it is a clue within a larger diagnostic toolset.

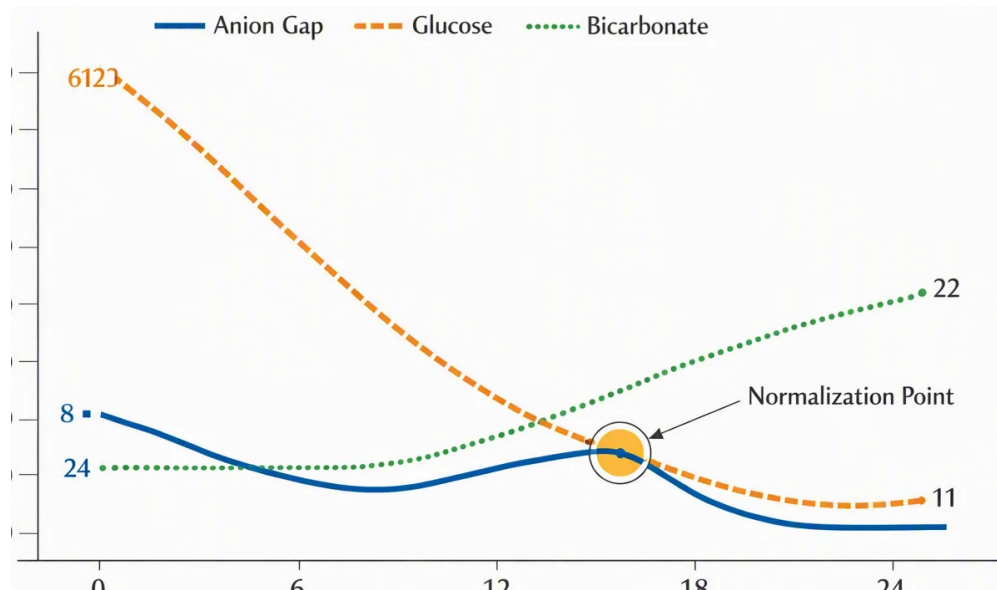
When to Seek Medical Follow-Up
