

What Does a Anion Gap Test?

An **anion gap test** is a simple way to help evaluate **acid-base disorders** by reviewing the relationship across common **electrolytes** in a lab sample. The calculation usually uses **sodium**, **chloride**, and **bicarbonate**, which are part of a standard **blood chemistry panel**. 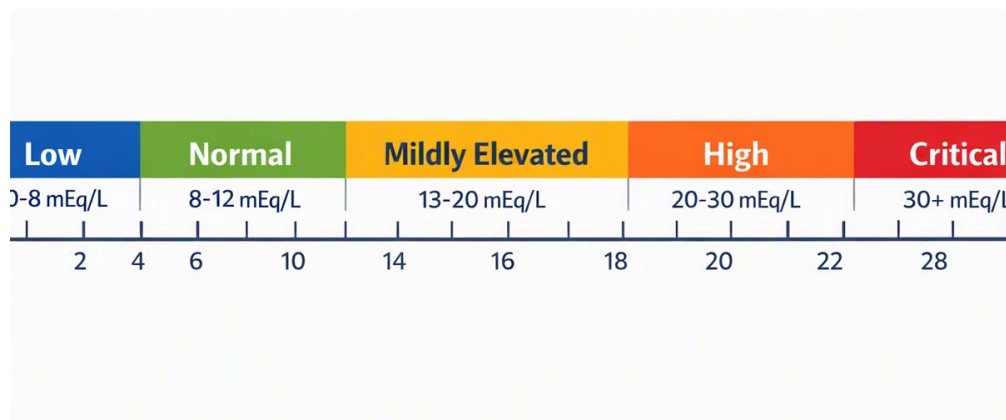
