

An **Anion Gap Calculator** is a handy means to calculate the **anion gap** from routine lab data. That means the calculator subtracts the sum of chloride and carbon dioxide from sodium. For example, if sodium is 140, chloride is 104, and CO2 is 24, the calculation is  $140 - (104 + 24) = 12$ . The calculation itself does not identify the toxin, but it can support timely recognition of an abnormal pattern.

On the other hand, a **reduced anion gap** may be associated with low albumin, laboratory artifact, or uncommon changes in serum proteins and ions. While less frequent than high values, a low result should not be ignored if it is unexpected or inconsistent with the patient's condition. It may require repeat testing or broader evaluation of the chemistry panel.

## Calculating the Anion Gap for Albumin

**Albumin adjustment** is an important measure when evaluating the anion gap, especially in patients with **hypoalbuminemia**. Since albumin is a main unmeasured anion, a low albumin level can make the anion gap look falsely normal or low. In these cases, the unadjusted result may miss the true acid burden.
