

When someone is shocked or burned on a job site in Georgia, there is usually more than one responsible party.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only [truck accident lawyer](#) part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.
