

What Is the Anion Gap?

The **anion gap** is a calculated value used in a blood test to help interpret the balance of **electrolytes** in the body. It is typically obtained from the main measured ions in a serum chemistry panel: **sodium**, **chloride**, and **bicarbonate**. Because not every charged particle is directly measured, the anion gap helps determine the difference between **measured cations** and **unmeasured anions**.

In simple terms, the anion gap is a helpful **diagnostic tool** for assessing **acid-base balance**. A normal result supports a ***anion gap in chronic kidney disease*** narrower range of likely causes, while a **low anion gap** or **high anion gap** can suggest different types of **acid-base disorder**. Clinicians often use an **electrolyte panel** or broader **serum chemistry** to calculate it as part of a **metabolic evaluation**.

The most common formula is:

Anion gap = Sodium - (Chloride + Bicarbonate)

Can Low sodium Change the Anion Gap?

Absolutely, a **sodium deficit** can influence the **anion gap** because sodium is included in the calculation. If the sodium value decreases while **chloride** and **bicarbonate** remain stable, the calculated gap may be lower. Still, the effect depends on the general pattern of **lab interpretation** and not just the sodium number alone.

Using an **anion gap calculator** can make clear how changes in **serum sodium** affect the result. This is a simple math effect, but the body's chemistry is considerably more complex than the formula alone suggests.

Bicarbonate and **chloride shift** can change the result in different directions.
