

If you or your child were bitten around Atlanta, Georgia works differently than people expect.

In some places an owner is liable automatically. That is not the Georgia rule. The question is normally whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

A leash law violation is often [truck accident lawyer](#) the clearer path, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
