

If an electrical injury happened at work in Georgia, the answer is rarely a single company.

There is the property owner, the general contractor, the electrical sub, sometimes the utility, occasionally an equipment maker, and ***injury claims lawyer Atlanta*** sometimes a staffing agency. Establishing who controlled the hazard requires the site contracts and the safety documentation, and none of that is available just for the asking.
