Risk and Validation: GO/NO-GO and Risk Registers

One of my pet peeves is AI tools that "promise risk assessment" but never clearly state what risks were identified or how validation is done. Suprmind Debate mode attempts to close that gap.

During a debate, each side flags potential risks or uncertainties tied to the proposition. These are then collected into a **risk register**—a valuable artifact for decision-makers to weigh. An automatic **GO/NO-GO recommendation** attempts to synthesize whether the proposition passes muster given known risks and counterarguments.
