

When a dog attack leaves someone hurt in Georgia, Georgia works differently than people expect.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether a complaint was ever filed.

This evidence does not last. Prior complaints and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
