

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one eventually, usually when the bills arrive or an insurer calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. [truck accident lawyer](#) The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious suffering before death.

Georgia law sets an order for who may bring that first claim. It generally begins with a surviving spouse, then children, then parents, and then the estate. Where there is [lawyer for truck accident settlement](#) a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, particularly where a commercial vehicle or a business is involved.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
