When disputes do develop, they frequently stem from varying analyses of maintenance obligations. Keeping clear and accessible paperwork can assist clarify these obligations and resolve misunderstandings. If a conflict seems unavoidable, try negotiation prior to turning to lawsuit.

Notice For Excavation Near A Neighbor

Just how close to a limit can you develop without an event wall surface agreement?

You can develop your extension as close as 50mm to your neighbour's border if you have actually Permitted Development Rights or Planning Approval, but if you want to construct directly on the boundary line, you require a Party Wall surface Contract, which normally involves alerting neighbors two months ahead of time.
