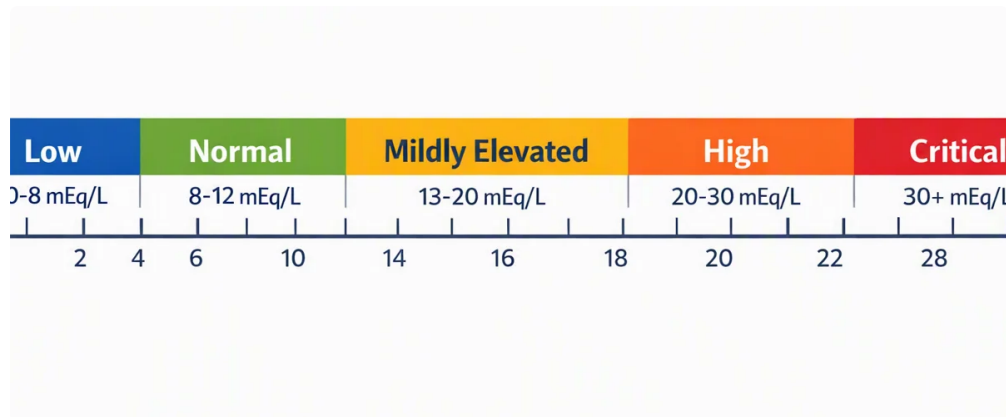


What an anion gap calculator is and its importance

An **anion gap** is a computed value that enables clinicians and patients understand whether an **acid-base balance** problem may be present, especially when evaluating **metabolic acidosis**. An **anion gap calculator** uses common **electrolytes** from a **serum chemistry panel** to estimate whether there are unmeasured acids in the blood. This makes it useful in **metabolic acidosis evaluation**, where the goal is to find the cause of acid accumulation and guide the diagnostic workup.
